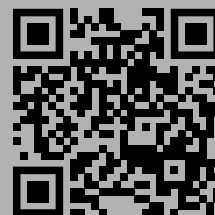

A Practical Example: Clarifying Liability Issues in a Contract

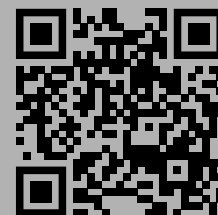
